Full Terms & Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. 7. How to enter

- a. Go to Facebook.com, Instagram.com or Twitter.com
 - b. Underneath the promotional post, tell us who is your everyday hero and why they should win. Please ask permission from your hero to nominate them.

- d. A person who enters the prize promotion is a Nominator ('Nominator'). The hero nominated in the entry is a Nominee ('Nominee')

- j. We will not tolerate anyone who posts or is seen to be posting comments via any social media channel or anywhere else during this competition that we think are bullying, spiteful or upsetting to other entrants and followers of Tesco or directly aimed at us. a.
