



McCoy's Terms and Conditions ("Promotion")

These Terms and Conditions govern the relationship between you, the entrant ("you", "your(s)", "entrant(s)"), the Promoter and the Administrator (both defined below) in relation to the Promotion and shall prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of these Terms and Conditions and by participating all entrants will be deemed to have accepted and be bound by these Terms and Conditions. Please retain a copy for your information.

1. **The Promoter:** Tesco Stores Ltd., Tesco House, Shire Park, Kestrel Way, Welwyn Garden City, AL7 1GA.
2. **The Administrator:** Prizeology Limited, 820 The Crescent, Colchester Business Park, Colchester C04 9YO. The Administrator is responsible for administering the entry mechanic of the Promotion and fulfilling the Prizes.
3. **The Supplier:** KP Snacks Limited, Fifth Floor, The Urban Building, 3-9 Albert Street, Slough, SL1 2BE, England.
4. The Promoter, the Administrator and the Supplier, together referred to as the "**Promotion Entities**".
5. **Eligibility:**
 - a. This Promotion is open to UK (England, Wales, Scotland and Northern Ireland) residents aged 18 years or over who: (a) have an email address; (b) have a mobile phone with a valid number; and (c) internet access.
 - b. Please ask the owner's permission before using a computer, device and/or internet-access which is not owned, or paid for, by you to enter this Promotion. The Promoter is not liable for any internet connection, mobile connection, or other charges incurred while entering this Promotion.
 - c. The following are not eligible to enter this Promotion: employees and their immediate families of the Promotion Entities, associated agents or anyone professionally connected with this Promotion, including without limitation,

advertising agencies, PR, prize suppliers and legal advisors. In these Terms and Conditions, "immediate family" includes mother, father, brothers, sisters, sons, daughters, partner or spouse members of such employees or of anyone with whom such employees are domiciled.

6. Promotional Period: This Promotion opens at 10:00 on **22nd April 2026** and closes at 23:59 on **2nd June 2026**. Entries received outside the Promotional Period shall not be valid for entry into this Promotion.

7. Entry Instructions:

During the Promotional Period:

a. Scan the QR code or go to bigticket2026.com;

b. Enter your first name, surname, postcode, mobile number and email address. Click enter.

c. "Open the box". The box will reveal either a "Win" or "Lose" message, dependent on whether the box is opened during a winning moment as set out in Clause 21.

("Entr(y)(ies)").

d. By entering this Promotion you agree that such Entry (excluding personal information) is deemed to be non-confidential and non-proprietary, and we shall have no obligation of any kind with respect to such Entries.

8. Please note that this Promotion appears cross-media with 5 different QR codes, but there is only one prize pool.

9. Only one entry per person per day during the Promotional Period. For the avoidance of doubt only one email address and valid mobile number will be accepted per person, and a person can use this email address and mobile number to enter only once per day. Any use by entrants of identities other than their own and/or any entrant using multiple email addresses, mobile numbers and/or any other methods to enter this Promotion will be disqualified and any prize entitlement will be void. An email address and mobile number can only be used by one person and cannot be shared within a household. The Promoter reserves the right to determine, in its sole

and absolute discretion, whether an entrant or household has already submitted an entry and to disqualify any subsequent entries or prize entitlement.

- 10.** No third party or bulk entries. Entries via third parties, consumer groups or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these Terms and Conditions in full will be disqualified. If it becomes apparent that either an entrant or household is using any means to circumvent this condition such as, and without limitation, fraudulently falsifying data; using multiple email addresses and mobile phone numbers; using multiple postal addresses; acting fraudulently or dishonestly in the opinion of the Promoter; using identities other than their own; creating fake identities or using any other automated or manual means in order to increase that entrant's or a household's entries or otherwise acting in violation of these terms, these entrants and their household will be disqualified, and any prize entitlement will be void.
- 11.** Illegible, incorrect and/or incomplete Entries will not be accepted or eligible to win a prize. No responsibility can be accepted for Entries that are illegible, incorrect, incomplete, lost due to technical reasons, corrupted, delayed or not received for whatsoever reason.
- 12.** We also reserve the right in our sole and reasonable discretion to disqualify any entrant who: (a) we have reason to believe has breached any of these Terms and Conditions; and/or (b) corrupts or affects the administration, security, fairness, integrity or proper conduct of this Promotion; and/or (c) engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of this Promotion. We also reserve our legal rights to recover damages or other compensation from such an offender.
- 13. Prizes:** There are 80 prizes to be won during the Promotional Period, being:

- 5 x Samsung 50in 4K TVs;
- 5 x £1,000 cash prizes;
- 70 x £100 cash prizes.

TV prizes will be sent to the address (postcode) provided at point of entry only, within 28 working days of prize acceptance.

£1,000 prizes will be paid via bank transfer to a UK Sterling bank account in the winner's name supplied at point of entry, within 28 working days of prize acceptance. The payment cannot be made into another person's bank account. The winner will need to provide a valid UK bank account number and sort code. Payment cannot be

made into a Non-Bank Financial Institution (NBFi) or Electronic Money Institution (EMI).

£100 prizes will be paid either i) via cheque in UK Sterling to a UK address and in the winner's name supplied at the point of entry, or ii) via bank transfer to a UK Sterling bank account in the winner's name supplied at point of entry within 28 working days of prize acceptance. The payment cannot be made into another person's bank account. The winner will need to provide a valid UK bank account number and sort code. Payment cannot be made into a Non-Bank Financial Institution (NBFi) or Electronic Money Institution (EMI).

Please note that all winners will be required to provide proof of identity documenting full name and age (date of birth), and proof of residential address, before a prize can be dispatched. Business or work addresses will not be accepted. Proof of identity and address must match the name and postcode supplied at point of entry. Only official documents can be accepted as proof of identity (driving licence, identity card or passport). Council tax will not be accepted as proof of identity. Expired proof of identity or address will not be accepted. A mobile phone bill will not be accepted as proof of address.

- 15. Maximum one prize per person.** The prize must be accepted as offered and redeemed by the named winners only. There is no cash or alternative prize, in whole or part (save where the Promoter in its sole discretion deems it reasonably necessary to provide an alternative prize). The prize is non-transferable and non-refundable. Sale of the prize for profit is prohibited and may constitute fraud. The prize cannot be combined with any other offer, promotion or discount.
- 16.** The Promoter reserves the right to provide alternative prizes of equal or greater value should circumstances outside our control make this necessary.
- 17.** The Supplier is responsible for sourcing and supplying the prizes for the Promotion.
- 18.** We reserve the right to verify winners and ask for proof of identity, age and address and to withdraw prize entitlement where there are reasonable grounds to believe there has been a breach of these Terms and Conditions.
- 19.** Prizes are subject to the terms and conditions of the prize suppliers.
- 20.** The winners will be solely responsible for paying any taxes in connection with the prizes and all other expenses not specifically detailed above.

21. Winner Selection:

- a. Prizes are allocated via guaranteed winning moments. Before the Opening Date, an independent third party will randomly select guaranteed winning moments (day, hour, minute and second) during the Promotional Period and randomly order 80 x prizes.
- b. If your time of entry when you open the box, and your entry is processed by the server, matches a winning moment you will be awarded the prize randomly pre-allocated to that moment.
- c. In the event that the box is opened at the same time by two entrants, the entry processed by the server first will be the winning entry.
- d. If no one enters at the winning moment, that prize will remain available until the next successful entry.

22. Winner Notification:

- a. In accordance with clause 7c, where the box reveals a “Win” message, the winner will be notified immediately on screen which prize they have been allocated.
- b. Winners will receive an email within 7 working days of their win. Winners will then have 14 days from receipt of this email to supply proof of ID and residential address, to claim the prize. If a winner does not respond within 7 days, the winner will be emailed again and given a further 7 days to respond. If contact cannot be made, or the prize is not claimed within 14 days of the initial notification date, prize entitlement will be withdrawn, and the prize will be allocated to a new winner during the Mop Up Draw in accordance with Clause 22c. Promotion Entities cannot be held responsible for winners failing to supply accurate information which affects prize acceptance or delivery of their prize.
- c. Any unclaimed, or withheld prizes, will be put into one random prize draw (Mop Up draw) of all eligible entrants, which will be conducted week commencing 6th July 2026. Each Mop Up winner will be sent an email to the email address used at the point of entry, and prize notification and acceptance will be carried out as set out in Clause 22a-b.

- 23. General:** The entry instructions form part of these Terms and Conditions. By entering, you agree to accept and be bound by these Terms and Conditions.
- 24.** The Promoter's decision is final and binding. No correspondence will be entered into.
- 25.** The Promoter reserves the right, at its sole discretion, to eliminate or disqualify any Entries or entrants that it regards as being in breach of these Terms and Conditions or the spirit of this Promotion. Those who try and circumvent the entry process and/or entry instructions by any method, will be disqualified and any prize award will be void.
- 26.** Entry into this Promotion is voluntary and at the entrant's sole decision and risk.
- 27.** Subject to Clause 28 below, the Promotion Entities will not in any circumstances be responsible or liable to the winners or any third party, or accept any liability for:
- a. any disappointment, loss, damage, personal injury or death occurring as a result of entry to this Promotion; and/or
 - b. any loss, damage, personal injury or death occurring as a result of acceptance and/or use of the prize.
- 28.** Nothing in these Terms shall limit or exclude the Promotion Entities' liability for:
- a. death or personal injury caused by negligence; and/or
 - b. fraud or fraudulent misrepresentation; and/or
 - c. any liability which may not be legally limited under applicable law.
- 29.** The Promotion Entities accept no responsibility for system errors or other issues that may result in disruption to, lost, delayed or not received entries, winner notifications or prizes. The Promotion Entities will not be responsible for the non-inclusion of Entries as a result of technical failures or otherwise, including any such failure which is within the control of the Promotion Entities.
- 30.** The Promoter reserves the right to disqualify any entries made using anonymous, disposable and or temporary email services such as, but not limited to, Apple, Guerilla Mail, Dispostable, and Mailinator as well as any programmatically generated or manually created email addresses on platforms including, but not limited to Outlook, Gmail, Yahoo Mail, or BT Internet domains, for the purpose of circumventing these Terms and Conditions. The Promoter reserves the right to determine, in its sole and absolute discretion if an entrant or a Winner has used any such service and

disqualify them from the Promotion, or withdraw prize entitlement.

- 31.** The Promoter reserves the right to cancel, amend, withdraw, terminate or temporarily suspend this Promotion in the event of any unforeseen circumstances or technical reason outside its reasonable control, with no liability to any entrants or third parties but will use all reasonable endeavours to avoid consumer disappointment and in the event of an early cancellation or termination of this Promotion, the Promoter will select winners from all valid and eligible Entries received prior to any such early cancellation or termination. Such circumstances include, but are not limited to: industrial action, civil unrest, fire, flood, storms, earthquakes, acts of terrorism, acts of war, governmental action or any other event that is beyond the control of the Promoter.
- 32.** The application and interpretation of these Terms and Conditions shall be governed by the law of England and the courts of England and Wales shall have exclusive jurisdiction in relation to any dispute concerning them.
- 33.** The Administrator will be operating and administering this Promotion, including without limitation, collecting and confirming Entries; contacting winners and sending out prizes. The Administrator will share your personal information with the Promoter, prize suppliers, a third-party fulfilment service provider (as applicable) for the purposes of administering the prizes. The surname and county of the winners will be made available to anyone who requests them by emailing McCoys@tescoprizes.com within 1 month of the closing date. Entrants may request their surname and county is not published in the event they win by emailing McCoys@tescoprizes.com before the closing date. Your details will not be passed onto any third party for any other purpose without prior consent. This data will be kept secure and in accordance with the requirements of the Data Protection Act.
