



## **WILKINSON SWORD QUATTRO - WIN ANTHONY JOSHUA FIGHT TICKETS - Text to Win Terms and Conditions ("Promotion")**

These Terms and Conditions govern the relationship between you, the entrant ("you", "your(s)", "entrant(s)"), the Promoter and the Administrator (both defined below) in relation to the Promotion and shall prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of these Terms and Conditions and by participating all entrants will be deemed to have accepted and be bound by these Terms and Conditions. **15. Prizes:** There is 1 prize in total.

- a. Prize is 1 pair (winner + 1 guest) of tickets to see Anthony Joshua's fight, in Autumn 2026 (October, November or December), and a separate meet and greet with Anthony Joshua at a private location in London, up to 2 months post-fight when the athlete is back in London. At least one person must be 21+ to attend the whole prize. The winner will be notified of the meet and greet date at least 2 weeks prior to the meet and greet taking place. **The tickets are only valid to watch a fight in Autumn 2026; in the event that a fight does not take place in Autumn 2026, then the Supplier will offer an alternative prize whereby the winner and guest get to attend a private talent-based boxing/training session in person with Anthony Joshua, including meet and greet at a private location in London, plus £500 total spending money towards travel and accommodation. The private meet and greet aspect of the original prize would be incorporated into this alternative prize. Exact date to be determined but this alternative prize would take place within 8-12 weeks of the winner being picked.**
- b. During the Promotional Period, if a fight is yet to be announced for Anthony Joshua in 2026 the winner and guest need to be aware that the location of the fight could be held at any of the following locations;

**16.** The prize must be accepted as offered and redeemed by the named winner only.
