



## Victoria Malaga - Text to Win Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating all entrants will be deemed to have accepted and be bound by the terms and conditions. Please retain a copy for your information.

1. **The Promoter:** Tesco Stores Ltd., Tesco House, Shire Park, Kestrel Way, Welwyn Garden City, AL7 1GA.
2. **The Supplier:** Damm Brewery UK Ltd. 5a Bear Lane, Southwark, London, SE1 0UH
3. **Eligibility:** This prize promotion is open to UK (England, Wales, Scotland and Northern Ireland) residents aged 18 years or over excluding employees and their immediate families of The Promoter, The Supplier, associated agents or anyone professionally connected with the prize promotion.
4. **Promotional Period:** The prize promotion opens at 00:00 on **18<sup>th</sup> October 2022** and closes at 23:59 on **6<sup>th</sup> November 2022**.
5. **Entry Instructions:**
  - a. Purchase any Victoria Malaga product in a Tesco store or online at Tesco.com during the Promotional Period from 00:00 on 18<sup>th</sup> October 2022 to 23:59 on 6<sup>th</sup> November 2022.
  - b. Text **MALAGA** or **MALAGA1** followed by a space, and your full name and postcode to 60110 by 23:59 on 6<sup>th</sup> November 2022.
  - c. Click on the link provided in the returned text message to upload a photo of your receipt to complete your entry by 23:59 on 6<sup>th</sup> November 2022. Only one photo can be accepted in a receipt upload.

Please retain receipt.

6. Please note that the promotion appears cross-media with 2 different keywords, but there is only one prize pool.
7. Participants must have a mobile phone able to send and receive messages to/from 5-digit short codes. Messages charged at network provider's standard network rate, but there is no charge to the participant for the returned bounce back text message. Texts are not usually included in any text inclusive packages, please check with your network provider if you are not sure of your standard network rate. Users on virtual mobile networks may not be able to text the short code. Please check with your network provider. Text lines are open 24 hours until 23:59 on the closing date. Ask the bill payer before texting. If you text after the closing date, you will not be entered but you will be charged. Take care when entering the text code; the Promoter is not responsible for mistypes and you may be charged at a higher rate. The Promoter does not accept responsibility for entries or claims that are delayed or not received due to transmission, network or software problems or any other reason beyond the Promoter's control.
8. Entry is by text only, but internet access is required for receipt upload.
9. Entry will be confirmed with a 'Thank You' response on the page upon uploading your receipt.
10. Entry is by text only. Only one entry per person during the promotional period (1 text & receipt = 1 entry). For the avoidance of doubt only one unique mobile number will be accepted per person, and a person can use this mobile number to enter only once. A mobile phone number can only be used by one person and it cannot be shared within a household. A receipt can only be used once per household. A receipt cannot be shared amongst entrants. Any entrant(s) using multiple mobile numbers or sharing receipts to enter the promotion will be disqualified and any prize void. The Promoter reserves the right to determine, in its sole and absolute discretion, whether a participant or household has already submitted an entry and to disqualify any subsequent entries or prize entitlement.

- 11.** No third party or bulk entries. Entries via third parties, consumer groups or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these terms and conditions in full will be disqualified. If it becomes apparent that either a participant or household is using any means to circumvent this condition such as, and without limitation, fraudulently falsifying data; using multiple mobile phone numbers; using multiple postal addresses; acting fraudulently or dishonestly in the opinion of the Promoter; using identities other than their own; creating fake identities or using any other automated or manual means in order to increase that participant's or a household's entries or otherwise acting in violation of these terms, these participants and their household will be disqualified, and any prize entitlement will be void.
- 12.** Proof of purchase will not be accepted as proof of entry. No responsibility can be accepted for entries that are incomplete, lost due to technical reasons, corrupted, delayed or not received for whatsoever reason.
- 13. Prize Fund:** There are 11 prizes (1x main prize and 10x runner-up prizes).

**Main prize:** There is 1 main prize consisting of 2x standard 2-day tickets to the Davis Cup in Malaga on 26<sup>th</sup> and 27<sup>th</sup> November 2022.

Prize also includes:

- Return economy flights from either London Luton, Manchester, Birmingham or Glasgow Airport to Malaga, departing Friday 25<sup>th</sup> November 22 and returning Monday 28<sup>th</sup> November 22.
- Return transfers from the airport to accommodation, and from the accommodation to Davis Cup;
- 3 nights' 4\* accommodation, sharing a double/twin room; Bed & Breakfast included.
- Entry to the Victoria Malaga brewery tour on Monday 28<sup>th</sup> November 2022.

Please note these dates are fixed and cannot be changed.

Prize excludes domestic transfers, travel insurance, meals and drinks, any required Covid-19 PCR tests, documentation, and any other expenses. Any restrictions/requirements for travel must be adhered to based on the guidelines at that time. Providing a valid passport and any necessary visas is the responsibility of the winner and guest. Winner and guest are also responsible for making sure they adhere to any Covid-19 and other entry requirements for Spain. The Promoter and Supplier cannot be held responsible for the winner and/or guest not having the correct travel documentation, test results, vaccine status or following any COVID-19 regulations.

**16. Winner Selection:** The winner and runners-up will be drawn using a random number generator on 7<sup>th</sup> November 2022.

**17. Winner Notification:** Winner will be notified by text on 7<sup>th</sup> November 2022. It is the responsibility of the participant to ensure that they respond to the winner notification, either by calling the Freephone number or emailing the address provided at the point of notification. Winner will have 3 days to accept the prize. If the winner or a runner-up does not respond within the initial 2 days, they will be texted again and given a further day to respond. If contact cannot be made, or the prize is not claimed, within 3 days of the initial prize notification date an alternative winner will be drawn, who will have 3 days to accept the prize.

Runners-up will be notified by text within 7 days of the closing date. It is the responsibility of the participant to ensure that they respond to the winner notification, either by calling the Freephone number or emailing the address provided at the point of notification.
