



Whole Earth Text to Win Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating all entrants will be deemed to have accepted and be bound by the terms and conditions. Please retain a copy for your information.

- 1. The Promoter:** Tesco Stores Ltd., Tesco House, Shire Park, Kestrel Way, Welwyn Garden City, AL7 1GA.
- 2. The Supplier:** Kallo Foods Limited, River View, The Meadows Business Park, Station Approach, Blackwater, Camberley, Surrey, GU17 9AB.
- 3. Eligibility:** This prize promotion is open to UK (England, Wales, Scotland and Northern Ireland) residents aged 18 years or over excluding employees and their immediate families of The Promoter, The Supplier, associated agents or anyone professionally connected with the prize promotion.
- 4. Promotional Period:** The prize promotion opens at 00:00 on 29th June 2021 and closes at 23:59 on 20th July 2021.
- 5. Entry Instructions:** To enter, text CYCLING or CYCLING1 or CYCLING3 followed by a space, and your name and postcode to 60110. Entries may only be submitted via text.
- 6.** Please note that the promotion appears cross-media with 3 different keywords, but there is only one prize pool.
- 7.** Participants must have a mobile phone able to send and receive messages to/from 5-digit short codes. Messages charged at network provider's standard network rate, but there is no charge to the participant for the returned bounce back text message. Texts are not usually included in any text inclusive packages, please check with your network provider if you are

not sure of your standard network rate. Users on virtual mobile networks may not be able to text the short code. Please check with your network provider. Text lines are open 24 hours until 23:59 on the closing date. Ask the bill payer before texting. If you text after the closing date, you will not be entered but you will be charged. Take care when entering the text code; the Promoter is not responsible for mistypes and you may be charged at a higher rate. If you are unable to send a text, please check with your network operator first. For technical issues only, call 0333 335 3351 between Monday and Friday from 9.30am to 5pm excluding public holidays. The Promoter does not accept responsibility for entries or claims that are delayed or not received due to transmission, network or software problems or any other reason beyond the Promoter's control.

- 8.** Entry will be confirmed with a 'Thank You' message response. There is no charge to the participant for this message.
- 9.** Entry is by text only. Only one entry per person during the promotional period. For the avoidance of doubt only one unique mobile number will be accepted per person, and a person can use this mobile number to enter only once. Any entrant using multiple mobile numbers or household sharing mobile numbers to enter the promotion will be disqualified and any prize entitlement will be void.
- 10.** No third party or bulk entries. Entries via third parties, consumer groups or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these terms and conditions in full will be disqualified. If it becomes apparent that either a participant or household is using any means to circumvent this condition such as, and without limitation, fraudulently falsifying data; using multiple mobile phone numbers; using multiple postal addresses; acting fraudulently or dishonestly in the opinion of the Promoter; using identities other than their own; creating fake identities or using any other automated or manual means in order to increase that participant's or a household's entries or otherwise acting in violation of these terms, these participants and their household will be disqualified, and any prize entitlement will be void.
- 11.** Proof of purchase will not be accepted as proof of entry. No responsibility can be accepted for entries that are incomplete, lost due to technical reasons, corrupted, delayed or not received for whatsoever reason.

12. Prize Fund: There is 1 prize, of a Team GB Cycling experience for your nominated primary or secondary school, located in the UK.

The whole experience will last for a total duration of 3 hours, and will consist of:

- a cycling session (workshop) for one school class with Ed Clancy and colleagues. A maximum of 30 children can participate in this session and must be able to ride a bike;
- A meet and greet/Q and A/photos for whole school with Olympian Ed Clancy.

Participating children should bring their own bike and helmet to the cycling session, however equipment will be provided for the duration of the session for those who do not have a bike or helmet.

The experience will take place on a mutually agreed date in October 2021. Prize will be subject to any Covid-19 rules, regulations or guidance. Any applicable Covid-19 rules, regulations or guidance must be complied with at all times. All elements of the prize will take place when safe and legally permissible to do so. Access to a school sports field or pitch will be required for the cycling session.

Upon prize claim, the winner will be asked to provide the name and contact details for their nominated school, for the Supplier to contact. The winner will be asked to provide a list of 3 schools, in preferential order. Should the first one decline, the second one will be contacted, and so on. The Supplier will liaise directly with the nominated school to accept and arrange their prize. Subject to the winner providing correct name and contact details for their chosen school the Supplier will liaise with the school beginning of September, subject to school summer holiday/half term dates.

13. Covid-19: The Promoter/Supplier shall not be liable in any way for its inability to meet these timeframes in the event of any national or local lockdowns, or any circumstances resulting from Covid-19, which affect prize fulfilment. Should Covid-19 affect the ability to meet these deadlines, the Promoter/Supplier will fulfil its obligations as soon as it is reasonably possible.

14. Winner Selection: The winner will be drawn using a random number generator within 7 days of the closing date.

- 15. Winner Notification:** Winner will be notified by phone call or text within 7 days of the closing date. It is the responsibility of the participant to ensure that they respond to the winner notification, either by calling the Freephone number or emailing the address provided at the point of notification. If the winner does not respond within the initial 7 days, they will be phoned or texted again and given a further 7 days to respond. If contact cannot be made, or the prize is not claimed, within 14 days of the initial prize notification date an alternative winner will be drawn. The Promoter cannot be held responsible for the winner failing to supply accurate information which affects prize acceptance or delivery of their prize.
