



Robinson's Win a Cricket Programme Place & Kit Text to Win Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating, all entrants will be deemed to have accepted and be bound by the terms and conditions. Please retain a copy for your information.

- 1. The Promoter:** Tesco Stores Ltd., Tesco House, Shire Park, Kestrel Way, Welwyn Garden City, AL7 1GA.
- 2. The Supplier:** Britvic Soft Drinks Ltd, Breakspear Park, Breakspear Way, Hemel Hempstead, Herts, HP2 4TZ.
- 3. Eligibility:** This prize promotion is open to Great Britain (England, Wales and Scotland) residents aged 18 years or over, excluding employees (and their immediate families) of the Promoter, the Supplier, associated agents or anyone professionally connected with the prize promotion.
- 4. Promotional Period:** The prize promotion opens at 00:00 on 21st June 2022 and closes at 23:59 on 12th July 2022.
- 5. Entry Instructions:** To enter, text CRICKET or CRICKET3 or CRICKET5 followed by a space, and your full name and postcode to 60110. Entries may only be submitted via text.
- 6.** No purchase necessary. Please note that the promotion appears cross-media, with 3 different keywords, but there is only one prize pool.
- 7.** Participants must have a mobile phone able to send and receive messages to/from 5-digit short codes. Messages charged at network provider's standard network rate., but there is no charge to the participant for the returned bounce back text message. Texts are not usually included in any

text inclusive packages, please check with your network provider if you are not sure of your standard network rate. Users on virtual mobile networks may not be able to text the short code. Please check with your network provider. Text lines are open 24 hours until 23:59 on the closing date. Ask the bill payer before texting. If you text after the closing date, you will not be entered but you will be charged. Take care when entering the text code, the Promoter is not responsible for mistypes and you may be charged at a higher rate. The Promoter does not accept responsibility for entries or claims that are delayed or not received due to transmission, network or software problems or any other reason beyond the Promoter's control.

- 8.** Entry will be confirmed with a 'Thank You' message response. There is no charge to the participant for this message.
- 9.** Entry is by text only. Only one entry per person during the Promotional Period. For the avoidance of doubt only one unique mobile number will be accepted per person, and a person can use this mobile number to enter only once. Any entrant using multiple mobile numbers to enter the promotion will be disqualified and any prize entitlement will be void. A mobile number can only be used by one person and it cannot be shared within a household.
- 10.** No third party or bulk entries. Entries via third parties, consumer groups or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these terms and conditions in full will be disqualified. If it becomes apparent that either a participant or household is using any means to circumvent this condition such as, and without limitation, fraudulently falsifying data; using multiple mobile phone numbers; using multiple postal addresses; acting fraudulently or dishonestly in the sole opinion of the Promoter; using identities other than their own; creating fake identities or using any other automated or manual means in order to increase that participant's or a household's entries or otherwise acting in violation of these terms, these participants and their household will be disqualified, and any prize entitlement will be void.
- 11.** Proof of purchase will not be accepted as proof of entry. No responsibility can be accepted for entries that are incomplete, lost due to technical reasons, corrupted, delayed or not received for whatsoever reason.

12. Prize Fund:

- a. There are 201 prizes in total. Each prize is a place on a Dynamos cricket programme in Summer 2023 for a child aged 8-12. The prize will consist of 8x 60-90-minute sessions (1 session per week for 8 weeks) with other children/prize winners, and a qualified coach.
- b. Prize is for a child who will be aged 8-12 in Summer 2023 only.
- c. Winners can choose a GB programme location available at <https://www.ecb.co.uk/play/dynamoscricquet>.
- d. Prize also includes a Dynamo kit for the child, consisting of 1x cricket bat, 1x ball, 1x bag and 1x personalised New Balance T-shirt (personalised name/number). T-shirt sizes subject to availability. The t-shirt's personalised name can be up to 10 characters long, including spaces and special characters. The t-shirt's personalised number can be up to 2 characters long. Any inappropriate messages or foul language will not be accepted.
- e. To receive the kit, winners will be required to provide name, child's name, email address, phone number, delivery address, T-shirt size (S, M, L, XL, XXL, sizes subject to availability), personalisation name and number. Kits will be dispatched by ECB within 30 working days of providing required details.
- f. Winners will be required to provide their email address and the name and date of birth of the participating child to receive information to book their cricket programme place. Winners will receive this information in March 2023.
- g. Cricket programme place must be taken between May and September 2023, subject to date and location availability.
- h. Prize excludes travel, accommodation, any other required kit and any additional expenses.

13. Winner Selection: The winners will be drawn using a random number generator within 7 days of the closing date.

14. Winner Notification: Winners will be notified by text within 7 days of the closing date. Winners have 7 days to claim their prize from date of notification. It is the responsibility of the participant to ensure that they respond to the winner notification, either by calling the Freephone number or emailing the address provided at the point of notification. Winners who do not respond within the initial 4 days, will be texted again or phoned and given a further 3 days to respond. If either

contact cannot be made, the prize is not claimed within 7 days of the initial prize notification date or a winner declines the prize within this timeframe, an alternative winner will be drawn and notified via the process described above.
