



## Pravha Win a Dining Experience with London in the Sky - Text to Win Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating all entrants will be deemed to have accepted and be bound by the terms and conditions. Please retain a copy for your information.

1. **The Promoter:** Tesco Stores Ltd., Tesco House, Shire Park, Kestrel Way, Welwyn Garden City, AL7 1GA.
2. **The Supplier:** Molson Coors Brewing Company (UK) Limited, 137 High Street, Burton-on-Trent, DE14 1JZ a company registered in England with company number 26018. Do not send entries to this address.
3. **Eligibility:** This prize promotion is open to UK (England, Wales, Scotland and Northern Ireland) residents aged 18 years or over excluding employees and their immediate families of The Promoter, The Supplier, associated agents or anyone professionally connected with the prize promotion.
4. **Promotional Period:** The prize draw opens at 00:01 on 27th May 2019 and closes at 23:59 on 18th June 2019.
5. **Entry Instructions:**
  - a. Purchase one of the following qualifying Pravha products: Pravha 660ml, Pravha 4x330ml, Pravha 12x330ml in a Tesco store.
  - b. Text **PRAVHA or PRAVHA1 or PRAVHA3 or PRAVHA5 or PRAVHA6** followed by a space, and your name and postcode to 60110.
  - c. Click on the link provided in the returned text message to upload a photo of your receipt to complete your entry. Only one photo can be accepted in a receipt upload.

Please retain receipt.

**Northern Ireland (NI) residents:** No purchase necessary. Text **PRAVHA or PRAVHA1 or PRAVHA3 or PRAVHA5 OR PRAVHA6** followed by a space, and your name and postcode to 60110 to enter. In order for the text to be accepted as an entry, it must be sent exactly as communicated above.

Please note that the promotion appears cross-media with 5 different keywords, but there is only one prize pool.

8. Entry will be confirmed with a 'Thank You' response on the page upon uploading your receipt.
9. Entry is by text only. 1 entry per receipt. Maximum 3 entries per person (1 text & receipt = 1 entry). For the avoidance of doubt only one unique mobile number will be accepted per person.
10. No third party or bulk entries. Entries via third parties or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these terms and conditions in full will be disqualified. If it becomes apparent that either a participant or household is using any means to circumvent this condition such as, and without limitation, fraudulently falsifying data, acting fraudulently or dishonestly in the opinion of the Promoter using identities other than their own or any other automated means in order to increase that participant's entries or otherwise acting in violation of these terms, these participants will be disqualified, and any prize entitlement will be void.

There are 33 x prizes consisting of a flight for 2 adults (18+) on the Pravha Sky Bar, including a set menu meal and drink on Friday 5th July 2019 beside North Greenwich Underground Station in London. Prize also includes a 2 night stay at the InterContinental 02 London (to be taken either Thursday 4th and Friday 5th July 2019 or Friday 5th and Saturday 6th July 2019) on a room only basis, based on a double or twin occupancy (subject to availability; if no rooms are available then an alternative hotel of equal or greater value will be provided), and £250 (two hundred and fifty pounds Sterling) travel/spending money in total, to be shared via bank transfer.
