

UEFA Women's EURO 2022 Flagbearer Text to Win Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating all entrants will be deemed to have accepted and be bound by the terms and conditions. - **3. Eligibility:** This prize promotion is open to UK (England, Wales, Scotland and Northern Ireland) residents aged 18 years or over excluding employees and their immediate families of The Promoter, The Suppliers, associated agents or anyone professionally connected with the prize promotion.
- **4. Promotional Period:** The prize promotion opens at 00:00 on 1st June 2022 and closes at 23:59 on 21st June 2022. There will be 1 draw per week (3 draws in total).
 - Week 1 opens at 00:00 on 1^{st} June 2022 and closes at 23:59 on 7^{th} June 2022. Week 2 opens at 00:00 on 8^{th} June 2022 and closes at 23:59 on 14^{th} June 2022. Week 3 opens at 00:00 on 15^{th} June 2022 and closes at 23:59 on 21^{st} June 2022.
- **5. Entry Instructions:** To enter, text FLAGBEARER or FLAGBEARER1 or FLAGBEARER2 or FLAGBEARER3 or FLAGBEARER4 or FLAGBEARER5 followed by a space, and your full name and postcode to 60110. Entries may only be submitted via text.

- **6.** No purchase necessary. Please note that the promotion appears cross-media, across Pepsi Max, Doritos and Walkers Max products, with 6 different keywords, but there is only one prize pool.
- 7. Participants must have a mobile phone able to send and receive messages to/from 5-digit short codes. Messages charged at network provider's standard network rate, but there is no charge to the participant for the returned bounce back text message. Texts are not usually included in any text inclusive packages, please check with your network provider if you are not sure of your standard network rate. Users on virtual mobile networks may not be able to text the short code. Please check with your network provider. Text lines are open 24 hours until 23:59 on the closing date. Ask the bill payer before texting. If you text after the closing date, you will not be entered but you will be charged. Take care when entering the text code; the Promoter is not responsible for mistypes and you may be charged at a higher rate. If you are unable to send a text, please check with your network operator first. For technical issues only, call 0333 335 3351 between Monday and Friday from 9.30am to 5pm excluding public holidays. The Promoter does not accept responsibility for entries or claims that are delayed or not received due to transmission, network or software problems or any other reason beyond the Promoter's control.
- **8.** Entry will be confirmed with a 'Thank You' message response. There is no charge to the participant for this message.
- 9. Entry is by text only. Only one entry per person per week during the Promotional Period. For the avoidance of doubt only one unique mobile number will be accepted per person, and a person can use this mobile number to enter only once per week. Any entrant using multiple mobile numbers to enter the promotion will be disqualified and any prize entitlement will be void. A mobile number can only be used by one person and it cannot be shared within a household.
- 10. No third party or bulk entries. Entries via third parties, consumer groups or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these terms and conditions in full will be disqualified. If it becomes apparent that either a participant or household is using any means to circumvent this condition such as, and without limitation, fraudulently falsifying data; using multiple mobile

phone numbers; using multiple postal addresses; acting fraudulently or dishonestly in the opinion of the Promoter; using identities other than their own; creating fake identities or using any other automated or manual means in order to increase that participant's or a household's entries or otherwise acting in violation of these terms, these participants and their household will be disqualified, and any prize entitlement will be void.

- **11.** Proof of purchase will not be accepted as proof of entry. No responsibility can be accepted for entries that are incomplete, lost due to technical reasons, corrupted, delayed or not received for whatsoever reason.
- **12. Prize Fund:** There are 8 prizes in week 1, 8 prizes in week 2 and 2 prizes in week 3 (18 total). Each prize consists of an England 'Flag Flagbearer Trip' experience for a child aged between 12 and 18 years' old during the UEFA Women's EURO 2022.

The winner may nominate a family member or family friend aged 12-18 to take part in the flagbearer experience; parental/guardian consent will be required. Alternatively, the winning entrant may take part in the experience provided they are aged 18 only.

Two chaperones, aged 18+ will be able to accompany the flagbearer to the experience. At least one chaperone must be a parent or legal guardian of the flagbearer.

Matches will be allocated as following (no choice of match):

Week 1 winners: The first 6 winners randomly drawn will be allocated Match 1 (Group Stage) – England vs Austria @ Old Trafford, Manchester at 20:00, on Wednesday 6th July 2022. The seventh and eighth winners randomly drawn will be allocated Match 10 (Group Stage) – England vs Norway @ Brighton & Hove Community Stadium, Brighton & Hove at 20:00, on Monday 11th July 2022;

Week 2 winners: The first 4 winners randomly drawn will be allocated Match 10 (Group Stage) – England vs Norway @ Brighton & Hove Community Stadium, Brighton & Hove at 20:00, on Monday 11th July 2022. The fifth, sixth, seventh and eighth winners randomly drawn will be allocated Match 17 (Group Stage) – Northern Ireland vs England @ St Mary's Stadium, Southampton at 20:00, on Friday 15th July 2022;

Week 3 winners: The 2 winners randomly drawn will be allocated Match 17 (Group Stage) – Northern Ireland vs England @ St Mary's Stadium, Southampton at 20:00, on Friday 15th July 2022.

Prize also includes:

3x category 1 tickets for the same match (2 for the chaperones, 1 for the flagbearer, sitting together);

a lunch box (for the flagbearer only);

A shirt, shorts, socks and drawstring bag for the flagbearer (this kit must be worn by the flagbearer during the experience);

and £350 cash for travel/accommodation/trainers (via cheque/bank transfer).

Tickets will be provided digitally, via email.

Prize excludes jackets (if required), trainers, any other meals and drinks and all other expenses. Flagbearers must bring and wear either adidas or unbranded trainers only.

If the Prize falls within school term time, the flagbearer must have school permission to attend the event. Prizes are subject to any applicable COVID-19 rules, regulations or guidance.

Flagbearers must arrive at the stadium 4 hours prior to kick-off, for the rehearsal.

The name/age/shirt size/short size/ any special mobility/dietary requirements of the flagbearer must be provided to accept the prize.

The name of the chaperones, and proof of relationship between flagbearer/at least one chaperone will also be required.

All details must be received by UEFA by 27th June 2022.

- **13.** Max one prize per person.
- **14. Winner Selection:** The weekly winners will be drawn within 2 days of the weekly draw closing date.

15. Winner Notification:

Week 1 winners will be notified by text within 2 days of the weekly draw's closing date.

Week 1 winners have 5 days to claim their prize. It is the responsibility of the participant to

ensure that they respond to the winner notification, either by calling the Freephone number or emailing the address provided at the point of notification. Winners who do not respond within the initial 3 days, will be texted again or phoned and given a further 2 days to respond. If either contact cannot be made, the prize is not claimed within 5 days of the initial prize notification date or a winner declines the prize within this timeframe, an alternative winner will be drawn and notified via the process described above the following working day and will have 5 days to respond. If either contact cannot be made within this timeframe, despite multiple attempts, or the winner declines the prize within this timeframe, an alternative winner will be drawn and notified via the process described above the following working day and will have 3 days to respond.

Week 2 winners will be notified by text within 2 days of the weekly draw's closing date. Week 2 winners have 5 days to claim their prize. It is the responsibility of the participant to ensure that they respond to the winner notification, either by calling the Freephone number or emailing the address provided at the point of notification. Winners who do not respond within the initial 3 days, will be texted again or phoned and given a further 2 days to respond. If either contact cannot be made, the prize is not claimed within 5 days of the initial prize notification date or a winner declines the prize within this timeframe, an alternative winner will be drawn and notified via the process described above and will have 4 days to respond.

Week 3 winners will be notified by text on the morning of 22nd June 2022. Week 3 winners will have 2 days (until 12pm 24th June 2022) to claim their prize. It is the responsibility of the participant to ensure that they respond to the winner notification, either by calling the Freephone number or emailing the address provided at the point of notification. If either contact cannot be made, the prize is not claimed or a winner declines the prize within this timeframe, an alternative winner will be drawn and notified after 12pm on 24th June 2022 via the process described above and will have 2 days to respond.

The Promoter cannot be held responsible for winners failing to supply accurate information which affects prize acceptance or delivery of their prize.

The Promoter reserves the right, at its sole discretion, to eliminate or disqualify any entries or entrants that it regards as being in breach of these terms and conditions or the spirit of the Promotion. Those who try and circumvent the entry process and/or entry instructions by any method, will be disqualified and any prize award will be void.

Such circumstances include, but are not limited to: industrial action, public health emergency, civil unrest, malware incident, fire, flood, storms, earthquakes, acts of terrorism, acts of war, governmental action / order or any other event that is beyond the control of the Promoter. The Suppliers bear sole responsibility for supply of the prize and Tesco cannot be held responsible for any claims relating to the prizes.
