



Jameson Text to Win Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating all entrants will be deemed to have accepted and be bound by the terms and conditions. - 3. Eligibility:** This prize promotion is open to England and Wales residents aged 18 years or over only excluding employees and their immediate families of The Promoter, The Supplier, associated agents or anyone professionally connected with the prize promotion.

- 4. Promotional Period:** The prize draw opens at 00:01 on 25th February 2020 and closes at 23:59 on 6th April 2020.

- 5. Entry Instructions:**
 - a. Purchase a bottle of Jameson 70cl in a Tesco store or online at Tesco.com during the qualifying period from 00:01 on 25th February 2020 to 23:59 on 6th April 2020.
 - b. Text JAMESON or JAMESON1 or JAMESON4 or JAMESON5 followed by a space, and your name and postcode to 60110 before 23:59 on 6th April 2020.
 - c. Click on the link provided in the returned text message to upload a photo of your receipt to complete your entry. If you have made a purchase online, please upload a photo of your order confirmation. Only one photo can be accepted in a receipt upload.

Please retain receipt.

Please note that the promotion appears cross-media with 4 different keywords, but there is only one prize pool.

- 6.** Participants must have a mobile phone able to send and receive messages to/from 5-digit short codes. Messages charged at service provider's standard network rate, but there is no charge to the participant for the returned bounce back text message. - 7.** Entry is by text only, but internet access is required for receipt upload.
- 8.** Entry will be confirmed with a 'Thank You' response on the page upon uploading your receipt.
- 9.** Entry is by text only. 1 entry per receipt. Maximum 2 entries per person (1 text & receipt = 1 entry). For the avoidance of doubt only one unique mobile number will be accepted per person, and a person can use this mobile number to enter up to 2 times. Any entrant using multiple mobile numbers to enter the promotion will be disqualified.
- 10.** No third party or bulk entries. Entries via third parties or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these terms and conditions in full will be disqualified.
